## 2024 PTDA Foundation Employee Scholarship Application

### General Information and Eligibility

The PTDA Foundation Employee Scholarship is open to those who are currently employed full-time at a power transmission or motion control distributor or manufacturer in North America. Applicants must be currently enrolled or recently accepted as a student at any level at a trade school, technical school, community college or university. Applicants must be studying power transmission or motion control related fields in engineering, technology or business. *Note:* This scholarship is only available to those currently employed within the power transmission and/or motion control industry. If you are not employed in the industry but enrolled in a power transmission/motion control field of study, please consider applying for the PTDA Foundation Student Scholarship.

The scholarship award is \$2,500 and is limited to one award per recipient. Scholarship applications are due July 1; awardees will be selected in August. The scholarship funds will be disbursed directly to the educational institution by September 30 and can be applied to an open tuition balance.
