### Step 1. Verify your company meets the requirements for PTDA Manufacturer Membership.

A firm, corporation or partnership which manufactures a power transmission/motion control product line, which operates through one or more facilities utilizing its business name located in North America which has a policy in force of distribution through authorized distributors, and which sells through power transmission/motion control (PT/MC) distributors.

The business entity must:

- (a) Manufacture\*, market, and support, under its own brand name through authorized distributors, at least one (1) power transmission/motion control (PT/MC) product line from the following categories:  
adjustable/variable speed drives, bearings, belt and chain drives, clutches and brakes, motor/motion control products, conveyors & material handling components, shaft couplings & u-joints, hydraulics & pneumatics, gearing (open/enclosed), motors, industrial specialty chemicals, linear motion products, pumps or other power transmission/motion control accessories.
- (b) Provide sufficient documentation to support its policy of using authorized distributors.
- (c) Market its products through a single sales force. Regardless of corporate structure, a business entity having more than one sales force for the marketing of its various product lines must have a separate and additional membership for each of its marketing divisions or participate only in the division for which it is paying dues.
- (d) Meet such other uniform criteria as established by the Board of Directors as noted below.
  1. \*Definition of manufacturing will include companies where the majority of their sales come from manufacturing, assembling or fabrication of their products. Specifically excluded are marketers, branders, packagers and slitters or importers.
  2. A manufacturer, as defined in the by-laws of PTDA and above, must own controlling interest in the operation in North America for that manufacturer to qualify as a Manufacturer Member. An executive from the operation in North America must be the PTDA representative.
  3. The North American operations of applicant manufacturers must include factory sales, warehousing & product support capabilities.
  4. **Applicants must provide with their application:**
    - a. **Evidence of operation of North American facilities by the applicant manufacturer.**
    - b. **A copy of their distributor policy.**
    - c. **Documents sufficient to show their distributor pricing policy.**
    - d. **Description of factory sales, warehousing and product support capabilities in the North American operation.**
    - e. **A \$1,000 application fee. Contact PTDA for payment options.**
  5. Applicants must provide a completed application on a form provided by PTDA.
